POSITION DESCRIPTION

The purpose of the position is to mobilize and demobilize our equipment and supplies using heavy diesel vehicles, including dump trucks. This includes various sizes of heavy equipment on trailers, towable machines, supplies, tools, and materials to and from our worksites.

This role also will include field support with general labor tasks and assistance for the day's site work. The job will include early mornings, overtime as needed, and the potential for occasional travel for work outside of NJ (with notice). We work outside and provide our services year-round.

CORE DUTIES AND RESPONSIBILITIES

- Perform daily work tasks under the guidance of the Operations Manager and/or Site Foreman.
- Proper execution of working load limits and minimums for tie-downs and securing cargo loads.
- Proper completion of Driver Log to ensure state and federal driver regulations are followed.
- Drive company vehicles and perform daily pre/post vehicle inspections using Whip Around (app).
- Use Slack (app) to receive daily schedules and communicate with co-workers and management.
- **Deep Foundation** site work activities include lifting, carrying, loading/unloading materials and supplies for the day's work and throughout the day, hand digging as needed, working with the grout plant and accessory tools and machines, daily cleanup of equipment, and work area.
- **Environmental Construction** services will include hand digging, confined space entry for tank cleaning, oil spill cleanup, drum handling, decontamination, sweeping and shoveling to clean up the work area, high-pressure washing, and related activities.

CORE DUTIES AND RESPONSIBILITIES (CONTINUED)

- Become familiar with machines and gas-powered tools necessary to run our sites.
- Come to work on time with a safe-work attitude and prepared with basic PPE requirements and any company-provided PPE.

QUALIFICATIONS

- Must be 18 years old
- Commercial Driver's License – Class A desired, tanker endorsement is great
- Responsible driving history. To drive our vehicles, you must be accepted by our insurance company which is based on a review of the last 5 years of your driving history (MVR).
- The ability to read, write and follow written and oral instructions in English
- The ability to lift, carry, and hold heavy job materials
- Pass pre-employment drug and alcohol test
- OSHA 10-hr Construction, 40-hr HAZWOPER industry training (training can be done online)
- AWS welding course certificate is a qualification that can raise employees into a higher pay range**.

**Employees who are interested and motivated to obtain their AWS welding certification will be supported. Monmouth and Ocean Counties have evening vocational training courses available at OCC and BCC, and we can provide that information if you request it.
